The Vermont Commission on Women supports the joint resolution, passed by the Vermont Senate and House, condemning the recently reversed federal policy of separating children from their families at the southern international border, expressing a profound hope that the family separation policy will not be reinstated, and imploring the Department of Homeland Security to reunite the separated families immediately.

# **MOTION APPROVED.**

### Deb moved to adopt the statement she proposed by e-mail, reading:

"The recent overwhelming reaction against separating 2000 children from their parents at the southern border underscores the common understanding of compassionate Americans that separation of children from their parents causes trauma and heartbreak to these children. It is our responsibility as American citizens to minimize the mental, emotional and physical trauma levied on children because of the loss of one or more of their parents. Sadly, as a result of government policies and cultural pressure, there are millions of American children separated from the parents they love and who love them, because they are being raised by single parents. In addition, reduced economic security, higher crime rates, lower life expectancy, lower educational achievement and increased mental health problems in children are the result of single parenthood, even when all other factors are equal. The Vermont Commission on Women, in keeping with our mission as advocates for the rights of women and children, use this opportunity, when Americans are focused on the plight of separated families, to make a public statement on to advocate for government policies and cultural norms that encourage families to begin together, and stay together."
