Updates

We have 1550 surveys completed, and staff is encouraging Commissioners to continue to distribute paper surveys at locations in their communities.

The Brattleboro Listening Project event will take place on Wednesday, September 26th at 6:00 p.m. at the Brooks Memorial Library; Emilie would like a poster designed. The event will be a facilitated, open conversation with prompt questions, and they will provide snacks.

The Newport event will be on October 5th, at noon, lunch will be served. It is invitation only; they have confirmed 19 participants plus seven planning committee members. They are pulling together representatives from service providers, community organizations, and have asked them to bring a client with them.
