# 1. Meeting Called to Order

Meeting called to order at 9:35 a.m.

## 2. Approval of Meeting Agenda

Motion made by Nancy, seconded by Hazel to approve the meeting agenda as submitted. Unanimously approved, agenda approved.

### 3. Review Group Agreements

The group took a minute to review the group agreements.

## 4. Approval of meeting minutes of May 2023

Motion made by Hazel, seconded by Nancy to approve the May 2023 meeting minutes as submitted. Unanimously approved, minutes approved.

#### 5. Introductions

The group introduced themselves by name and region.

#### 6. Staff Updates

Cary shared that VCW is planning public education around the passage of the bill to prohibit child marriage. Jessica share that S.103 was not passed but is on the calendar for the upcoming veto session.

Karen shared an update on the Health Equity Committee and presented a draft of the Transgender Individuals Policy. The group offered suggested edits and expressed the preference for a strong, broad statement over one that includes details that could end up being limiting in the future. Alex shared statistics with the group about how transgender youth are doing and shared personal experiences to underscore the importance of adopting a policy as soon as possible. The group agreed that adopting a policy this month is important and asked about the process. A special meeting would need to be called to vote on the final draft of the proposed policy. The Health Equity Committee will finalize the updated language and bring it back to the full Commission for approval.

Lisa called a special meeting end of June. A date will be scheduled by email.

Ellie shared an update from the Workplace Equity Committee and asked for help from commissioners to reach out to those organizations that signed the Equal Pay Compact.

## 7. FreeHer Campaign

Guest Jayna Ahsaf of the National Council for Incarcerated and Formerly Incarcerated Women and Girls presented information on their FreeHer Campaign. Policy, reimagining communities: providing basic income, and shifting the narrative: events, canvasses, and phonebanks, in attempts to "bring the power back to the people."

- Covered subjects such as de-incarceration, second-chance legislation for older populations, abolitionist alternatives, and offered the example of Hawaii which ended youth incarceration by offering indigenous programming.
- Asked for support in advocating for bills H. 445 and alternatives to incarceration H. 438.

Ashley elaborated on the cost of prisons, and offered a personal perspective of furlough.

#### 8. Election of VCW Chair

Motion to begin the election of the VCW Chair made by Nancy. Brenda seconded.

Sarah Mell and Esther Charlestin were nominated at the previous meeting and ran as co-chairs. They presented some thoughts on how they would fill the role of co-chairs.

Unanimously approved.

# 10. Operationalizing DEI in VCW's work

Cary returned to the Lotus Blossom Diagram offered by May's guest, Shalini Surayanarayana.

The group brainstormed "How might we advance the diversity mission in our daily work?" Some of the items in the discussion included:

- Giving space to stories and impact
- How are we including the communities we are representing?
- How do we center accessibility?
- Who are our advisors? Intentionally knowing.
- By reducing barriers
- Community engagement: who is not here because they cannot afford to be here?
- Hard of hearing, visually impaired?
- Inviting youth (be in touch with education admin/educators)
- Pier diems increased?
- "We have not yet talked about race"
- Appointment process: diversity in race, age, SES
- Consider our advisors
- Outreach efforts: introduce ourselves.
- Offering Public Forum
- Look to outside organizations that could fundraise for stipends, whether it be advisors attending meetings, or youth.
- Collaboration
