New data-dashboard: The COVID-19 Crisis and Vermont Women

VCW has released a brand new [data dashboard report](#) focusing on the ways the COVID-19 pandemic has disproportionately and uniquely impacted women.

"The economic downturn associated with the pandemic makes women more vulnerable to financial instability," said Cary Brown, the commission's executive director, "Our dashboard reveals that a higher percentage of April's unemployment claims were made by women: 46% vs. 40% by men.

The Commission's Data Management Coordinator, Anna Brouillette, commented on those disparities, "Ongoing gaps for Vermonters of color - both in COVID-19 case data and in the disproportionate wage gaps experienced by women of color in our state, remind us of the importance of examining and discussing the nuance and complexity of women's experiences."

VCW comments on new Title IX Regulations

In May, the US Department of Education announced new regulations to Title IX of the Education Amendments Act of 1972, governing how educational institutions, including colleges and universities, respond to allegations of sexual harassment, sexual assault, domestic violence, dating violence, and stalking. New inmate at women's prison tests positive – after contacting three others

[An incoming inmate tested positive for Covid-19 at Vermont's only women's prison on Saturday after coming into contact with staff and other prisoners, the Scott administration announced Monday morning](#). Agency of Human Services Secretary Mike Smith said facility-wide testing is now underway at the Chittenden Regional Correctional Facility, per Vermont's policy of conducting blanket testing whenever a positive case is linked to a group living facility.

Congratulations to UVM Professor Emily Bernard, Named a 2020 Andrew Carnegie Fellow | Seven Days

The University of Vermont English professor is fresh off winning the Christopher Isherwood Prize for autobiographical prose in the Los Angeles Times 2020 Book Prizes competition. That was one of numerous accolades for her 2019 collection of autobiographical essays *Black Is the Body: Stories From My Grandmother's Time, My Mother's Time, and Mine*. [Bernard was named a 2020 Andrew Carnegie Fellow by the Carnegie Corporation of New York](#). The fellowship includes a \$200,000 prize, given to scholars to support "research in the humanities and social sciences that addresses important and enduring issues confronting our society."

Q&A: New Burlington Police Commission chair on defunding, oversight authority | VTDigger

Jabulani Gamache was unanimously elected chair of the Burlington Police Commission June 2, just over a week after a white police officer killed George Floyd in Minneapolis, sparking nationwide protests. Now, Gamache is leading the commission as hundreds of members of the public call for cuts to police funding, including a 30% reduction in uniformed officers, removing officers from schools, and the firing of Officers Jason Bellavance, Cory Campbell and Joe Corrow, all of whom are named in the police brutality lawsuits. [Gamache spoke with VTDigger](#) about why he favors cutting the police department budget, why he thinks the commission should have more authority, and why he decided to join the commission.

Bennington Agrees to Settle Racial Profiling Case | ACLU-VT

A civil rights lawsuit brought by Shamel Alexander against the Town of Bennington and its police department [has been settled out of court, with the city agreeing to a \\$30,000 cash settlement to resolve claims of systemic racial profiling by Bennington police](#). This settlement comes two months after the International Association of Chiefs of Police (IACP) issued a series of recommendations for reforming the BPD. The IACP report catalogued numerous deficiencies in BPD, describing a department badly out of step with best practices, exhibiting a “warrior mentality,” and deeply mistrusted by Bennington community members.

Doug Hoffer: The time is ripe to reinvent our public safety system | VTDigger Commentary

“A few years ago, my office examined the total amount spent in Vermont for public safety by state and local governments. We found that a total of \$574 million was spent on public safety in Vermont in fiscal year 2017. We didn’t pass judgment about whether that was too much, too little, or just right. But it is unquestionably a great deal of money. For context, that total equated to roughly 37% of the state’s general fund appropriations that year.

The question for policymakers is whether the current system is optimal. Does it

provide Vermonters with a just and safe society? Is it cost effective? Does it minimize redundancies? Are services equitably distributed around the state? Does it disproportionately affect minority and marginalized populations? How well does the system balance prevention and enforcement?" [Read more.](#)

Rather, it has left it to appeals courts, including the U.S. Supreme Court which has shown a bias in favor of law enforcement, to decide the meaning of the bill's most critical word using rules of statutory construction." "A news photo from a protest in Essex Junction showed three young women holding a large cardboard sign that summarized where we are: "*All Lives Don't Matter Until Black Lives Matter.*" If, as a country, we reach a point where we truly believe and behave as though *Black Lives Matter*, we can put that statement in the history books. We could then paint *All Lives Matter* on our streets and it would be true. Black inmates make up a disproportionate share of Covid-19 cases in prison | VTDigger

Data from the Vermont Department of Corrections shows that while Black inmates were almost 9% of the total prisoners tested for Covid-19 in the state, [they made up nearly 18% of the prisoners who have tested positive for the coronavirus](#). Black inmates were also 2.2 times more likely to test positive than white inmates.

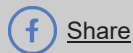
